While the current City Council has issued Certificates of Obligations to fund needed community projects, the expenditures are in-line with the amount of CO bonds issued by the previous Council. Even with these new projects, the current debt rate remains well below the 10.06 cent level approved by voters during the 2004 bond election.

Since 2006, the City has added a net of 17 non-civil service employment positions. Five storm water positions were added to meet upcoming Federal EPA requirements. In addition, 12 street and park maintenance positions were added to provide for the ongoing upkeep of our city assets.
